PROPERTY ASSESSMENT SENIOR REBATE PROGRAM FY2019-2020

The City of Emeryville is offering property assessment rebates to qualifying seniors for the Property Based Improvement District (PBID). To qualify for the Senior Rebate Program, you must satisfy all three (3) requirements below:

- 1. Must have owned and occupied the residence as of July 1, 2019, and are currently occupying said residence; and
- 2. Alameda County property taxes must be paid in full by April 30, 2020 and
- 3. Must be 65 years of age or older as of December 31, 2019.

NEW APPLICANTS

If you satisfy all of the program requirements, complete the attached application form and provide the following documents with your application:

- Proof of Age (e.g. Driver's License, California Identification Card, Birth Certificate, Medi-Cal Card, or Passport); and
- Copy of 2019/2020 Alameda County Property Tax Bill; and
- Complete a W-9 Form.

Please note that your continued eligibility for this exemption must be confirmed each year.

RETURNING APPLICANTS

If you satisfy all of the program requirements, and had received a refund the previous year, you will only need to complete the attached application form and return with a copy of your 2019/2020 Alameda County Property Tax Bill.

REBATE CHECKS WILL BE MAILED MAY/JUNE 2020

Spouses or Registered Domestic Partners are eligible if they meet the above requirements. Relatives of deceased property owners are NOT eligible.
